And whereas it is necessary to declare the aims and objects of the public charitable trust, being constituted under these presents.

1. Now this Indenture witnesses as follows:

That, in order to effectuate his aforesaid desire, the Managing Trustee has set apart and handed over to the trustees, a sum of Rs. 51,000 (Rupees Fifty One Thousand only) (hereinafter called the "Trust Fund" which expression shall include cash and any other property of investments of any kind whatsoever in to which the same or any part thereof might be converted, invested or varied from time to time which may be acquired by the trustees or may come to their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to these presents), and the trustees shall hold and stand possessed of the same upon the trust subject to the powers, provisions, agreements and declarations hereinafter contained.

2. That the objects for which this trust is established are:

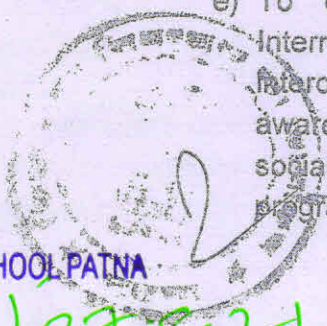

the past members. No members of the Trust shall have any personal claim on any movable or immovable properties of the Trust or make any profits, whatsoever, by virtue of his membership.

- K) To accept loan, Grant-in-aid, donation (either in cash or kind), subsidy or other assistance lawfully, either from National and/ or International agencies for the attainment of the objective of the Trust.
- L) To provide food, shelter, clothing, finance, equipment, medical care and education to the needy and disabled persons and to provide relief of people in distress due to war, natural calamities like earthquake, flood, famine, epidemics and conduct or grant donations for the support of orphanages and welfare institutions or any other activity for the relief of the poor.
- M) To invest, buy, and own art objects to encourage artists and artisans, hold seminar and training programme for art and cultural upliftment and protect Indian heritage by supporting art charities.
- N) To undertake any other activities that are conducive or incidental to the attainment of main objects of the Trust.
- O) To undertake any other activities as decided by the board of Trustees from time to time.

1. **BOARD OF TRUSTEES:**

- i. The management and the control of the Trust and its properties shall vest in the Board of Trustees. The Board of trustees shall comprise of minimum three and Maximum nine Trustees. The above number shall include permanent trustees.

- ii. There shall be two categories of Trustees one "Permanent Trustee" and other "Associate Trustees". The "Permanent Trustee" is one who will be of regular in nature and "Associate Trustee" will be appointed by the permanent trustees normally for a period of two years. - iii. Associate Trustees will hold office for a period of two years or for such lesser period as the Board of Trustees may decide from time to time but shall be eligible for reappointment in the manner stated in these presents.

2. **APPOINTMENT OF THE NEW TRUSTEES:**

If the Trustees of THESE PRESENTS die and / or desire to retire or refuse to or become incapable to act in the Trust or take the benefit of insolvency law for the time being in force or become of an unsound mind or bankrupt or insolvent, or otherwise be disqualified by operation of law or if any Trustees without leave of absence remains absent from three consecutive meeting of the board of Trustees, then in every such case it shall be lawful for the surviving or continuing Trustees for the time being of THESE PRESENTS to appoint new Trustee or Trustees in place of the trustee or trustees should living or desiring to retire or refusing or becoming incapable to act or taking the benefit of the insolvency law, or failing to attend three consecutive meeting of the trustees without leave given and upon every such appointment or vacancy, the number of trustees for the time being or THESE PRESENTS shall not be less than three and more then nine in numbers. Any vacancy out of permanent trustees so filled or any Trustee appointed / selected by the Managing Trustee as a Permanent Trustee shall be called as "Permanent Trustees" and shall have power and authority of the same or otherwise defined at the time of appointment.

3. **SELECTION AND APPOINTMENT OF NEW TRUSTEES:**

Upon every appointment made in pursuance of the last foregoing clauses thereof, the newly appointed trustees shall have all powers and authorities of the outgoing trustees or for a position to which one was appointed under THESE PRESENTS.

4. **NUMBER OF TRUSTEES**

The number of Trustees including the permanent Trustees shall not be less than 3 (Three) and not more than 09 (Nine) persons. The Settler of the Trust (The Managing Trustee) shall nominate and invite person / persons to be the Permanent Trustee or the other trustees for such period, as they may deem fit and proper.

5. TERM OF OFFICE OF THE TRUSTEES:

These Trustees shall hold office for such duration as may be specified by the board of trustees. Normally, the office of a Permanent Trustee will be for the life time and the Associate Trustee for a period of a maximum of two years or as specified in the terms of contract with him. However, the Trustees may be terminated in accordance with the rules mentioned in the preceding paragraphs. (at Para 9)

6. MANAGING TRUSTEE:

There shall be a Managing Trustee (or the settler of the Trust) for the administration of this trust, who shall be one amongst the above named Trustee for such period, in such manner as may be specified in this behalf.

- a) The Managing Trustee (in abbreviated form – 'M.T.') shall be the head of the Trust. He shall guide and supervise the various activities of the Trust. The ruling of the Managing Trustee shall be final and binding for any activity or on any question raised at the meeting.
- b) The tenure of Managing Trustee will be for the life time or till such time he relinquishes the position in favour of some other Permanent Trustee or a person of his family.
- c) The Managing Trustee shall have the rights to call meetings of the Board of Trustees, and decide the venue, date and time. The M.T. may advise the secretary to call such meeting.
- d) The Managing Trustee shall preside over the Meeting of the Board of Trustees. If in any meeting The M.T. is not available then the members to the Board to Trustees present shall elect one of them as Chairperson of the meeting.
- e) The Managing Trustee in case of emergency, may exercise all the powers and perform all the functions required to be exercised and performed under these rules, the Board of Trustees provided that all such actions taken by the M.T. shall be placed before the Board of Trustees in the next meeting immediately following the exercise of such powers and functions by the M.T.

- f) The MT will have power to install any decision of the trust for a period of six months and he can utilize this veto power twice for any decision.
- g) The MT will have absolute power of appointment to any position of the work under the trust or even the trustee of the Trust.
- h) The Managing Trustee may inspect any institutions belonging to the Trust to see its proper functioning and working. The Managing Trustee may apply his emergency powers for the betterment of such institution, If he thinks fit subjects to post facto approval by the Board of Trustees within three months.
- i) The Managing Trustee shall operate Bank Account with the other authorize Trustee or any other Trustees or any person authorized by the Board of Trustees.
- j) The Managing Trustee will have power to authorize any Trustee to sign the cheque book mentioning the limit of withdrawal. One of the Trustees will be authorized to work as a cashier who will be responsible for the safe custody of the fund and the cheque book.
- k) The Managing Trustee shall have power to spend any amount as per as the requirement and interest of the trust.

#### 7. OPERATION OF THE BANK ACCOUNT:

The fund of the trust will be kept in one or more reputed banks and it will be operated by such person selected by the Managing Trustee. Cheque book will be signed by the Managing trustee and the persons authorized by him. MT will be authorized to withdraw upto Rs 50,000 from a single cheque with his signature. Authorised trustees is empowered to withdraw Rs 10,000/- from a single cheque with single signature. But Rs. 50,000/- (Rupees fifty thousand only) can be withdrawn through any cheque signed by any two authorised Trustee. However, if the cheque is signed by the Managing Trustee along with any other authorized trustee, then unlimited amount can be withdrawn.

#### VACANCIES:

Any vacancy among the members of the Board of Trustees may be filled by the above named trustee and they shall hold

9. **TERMINATION OF OFFICE OF THE TRUSTEES:**

(a) Trustee shall cease to hold office:

- i. if he dies,
- ii. if he resigns,
- iii. if he is adjudged insolvent or found guilty of an offence involving moral turpitude.
- iv. if he is found to have acted against the interest of the Trust.
- v. if it is unanimously decided by the above named Trustees that his continuation in the Office is against the interest of the Trust.
- vi. Upon expiry of the period up to which the Board of trustees have nominated the trustee,
- vii. If in view of the Managing Trustee the person is no more useful for the trust or not acting in the manner he was expected to behave and act or his presence was detrimental to the interest of the Trust then he may be asked to relinquish his position and resign from the Membership of the Trust.

10. **BORROW OF MONEY FOR THE PURPOSE OF THE TRUST :**

The trust may borrow money on such terms and condition as deemed fit to carry out the functions of the Trust from any organization, financial institution or banks or accept any donation from any individual, institution or anonymous body. It may take loan from any bank for the construction of its building or any other function if so decided by the Trust in a meeting.

11. **MEETING AND PROCEEDINGS OF THE TRUSTEES:**

The Trustees shall ordinarily meet once in every three months or as often as may be necessary for the satisfactory conduct of the affairs of the Trust. All the meetings of the Trust shall be called by the Managing Trustee of the Trust.

- a) Decisions at a meeting of the trust shall be by a majority of vote.

- b) At least seven days previous notice of meeting shall be given to members for ordinary meeting and a day's notice for emergency meeting, provided that in case of urgency, if the Managing Trustee so thinks fit, a resolution without any meeting can also be passed and circulated.

- d) One third (1/3rd) of the Board of Trustees would be the Quorum for any meeting

# 15. POWERS, FUNCTIONS AND DUTIES OF THE TRUSTEES:

(b) To accept any trust, trust fund of endowment so long as the provisions of such Trust of endowment are in consonance with the objects of this Trust.
  - v. To award scholarship and make donations calculated to promote the objects of the Trust.
  - vi. To enter into contracts, or engagements on behalf of the Trust.
  - (vi) To consider such proposals submitted by Sub-committee appointed by this trust and allocate such funds if necessary as deemed necessary for the implementation of the programs.
  - vii. To make, sign and execute all such documents instruments, as may be necessary or proper for carrying on the management of the properties and affairs of the Trust.
  - viii. To enter into partnership on behalf of the Trust with any OTHER PARTY or parties,
  - ix. To invest such monies and such funds of the trust and to vary the investment as and when it may seem necessary

  - b. The premium for the insurance of the buildings or any other insurable property movable or immovable for the time being forming part of the trust property.
  - c. The costs of ordinary repairs and for providing any amenities to the buildings for the time being forming part of the trust property.
  - d. The cost of making such additions / alterations or improvements to or in the buildings forming part of the trust property, as the trustees shall think fit.
  - e. Wages and salaries of any manager, supervisor, accountant, clerk, servant or other employees employed by the trustees in the carrying out of this trust.

16. BANK ACCOUNT:

- i. The Trustees may from time to time open and maintain in the name of the Trust any bank accounts with such scheduled bank or banks or central and provincial co-operative bank or banks as may from time to time be determined by the Trustees and shall forthwith pay or cause to be paid the rents, income, profits, dividends and all other moneys forming part of the Trust Fund to the credit of any such account or accounts.
